附录 Appendix

一、入会基本条件 Basic Requirements for Membership

1. 凡参与新中经贸有关活动的工商企业及个人均可申请入会；
All enterprises and individuals participating in Singapore-China economic and trade activities are eligible to apply for membership;
2. 填妥入会表格，并附上公司商业注册或个人有效身份证件(IC/FIN)影印本一份；
Applicants must duly complete the membership application form and submit a copy of the company's business registration certificate or a valid personal identification document (IC/FIN);

二、会员的基本权益 Privileges and Benefits of Members

1. 有选举及被选举权；有权参加会员大会并有发言及表决权；
Members shall enjoy the right to elect and to be elected, and the right to attend general meetings with speaking and voting rights;
2. 在新中经贸活动中面临难题者，可向总会反映并要求给予协助；
Members encountering difficulties in Singapore-China economic and trade activities may approach the Chamber for assistance;
3. 有资格参与我会举办的各类型活动；
Members are entitled to participate in various activities organised by the Chamber;
4. 有资格参与接待来自境内外考察团活动；
Members are eligible to take part in receiving visiting delegations from within and outside the country;
5. 有资格参与我会组织的各类投资、贸易考察团；
Members are entitled to join investment and trade delegations organised by the Chamber;
6. 可申请总会名誉赞助各类符合总会会务宗旨的活动；
Members may apply for the Chamber's honorary sponsorship for activities that are in line with the Chamber's purposes;
7. 享受总会章程所规定的其它权益。
Members shall enjoy all other rights as provided for under the Articles of the Chamber.
